

## TERMS & CONDITIONS IN HIM CONFERENCE 2024

This website is operated by Glorious Gospel Church (ABN 73 294 378 005) ("GGC Life"). Your purchasing of a ticket to IN HIM Conference 2024 ("Registration") is subject to these terms and conditions. If you would like to ask any questions or exercise any rights outlined in these terms and conditions, please contact ggclife@ggclife.com. If you are registering a child for the conference, you warrant that you are a parent/guardian of the child registered.

- 1. Purchase of Registration: All prices clearly indicate the currency you will be charged and are inclusive of relevant taxes where applicable. You must pay for the Registration at the time of placing your order. GGC Life will issue an invoice to you when your payment has been successfully processed. Payment is by Amex, Visa or MasterCard only. GGC Life is not responsible for any bank fees that may be charged to you by third parties for the purchase of the Registration. Please check your contact details carefully before submitting your order. GGC Life may accept or reject the purchase of a Registration at its discretion, including (without limitation) if the payment method appears fraudulent, or there is an error in the price or description of the Product. If GGC Life rejects your order, we will endeavour to notify you of that rejection.
- 2. Delivery: Upon successfully purchasing the Registration GGCLife will confirm your purchase of your Registration via email within 24 hours.
- 3. Reassigning Registrations: If you would like to reassign your registration to another person, please contact GGCLife in writing before 1 March 2024.
- 4. Refunding Registrations: If you would like to cancel your registration to IN HIM Conference '24 and receive a refund, please contact GGC Life in writing before March 2024.
- 5. Delay, Reschedule or Cancellation of IN HIM Conference: GGC Life reserves the right to change any of the published event details and have the final determination



on any matter relating to the event. If IN HIM Conference 2024 is subject to change, GGC Life will endeavour to notify you within a reasonable time of such changes. For delays, rescheduling or cancellation of IN HIM Conference please refer to clause 8 (COVID-19)

- 7. Travel and Accommodation: GGC Life recommends that you confirm your registration with our office prior to booking any flights or accommodation. GGC Life does not accept responsibility for losses incurred for flights or accommodation booked for Live Events. You may also wish to consider taking out a relevant insurance policy to cover for any losses in the event of delay, rescheduling or cancellation.
